ADDITIONAL INFORMATION

New Business Credit (NBC): New Business Credit is calculated on a percentage of production annualized premiums.

Production: Requirements must be met through the production of Mutual Trust life and annuity products.

Summit Standings: The Summit standings are updated at the end of each business day under the Summit section of the Agent Website.

Co-General Agents: Co-General Agents need double the agency production requirements for both General Agents to qualify for either the President's Club or Chairman's Club.

Qualifications: Qualifications for the Summit include expenses for the qualifier and spouse or guest. It is company policy that the "guest" may not be a producer contracted with Mutual Trust. A producer may not attend either Summit event unless he/she has qualified on his/her production.
