3. Incentive qualification reports will be available on the GWIC agent portal.
4. Qualifying policies only include GWIC's Final Expense insurance products.
5. GWIC reserves the right, in its sole discretion, to cancel or change the incentive program rules at any time.
6. Agents must remain in good standing and be actively contracted with GWIC at the time of payout.
7. The value of any award will be reported as income to the awarded recipient in accordance with the rules and regulations of the Internal Revenue Service.
