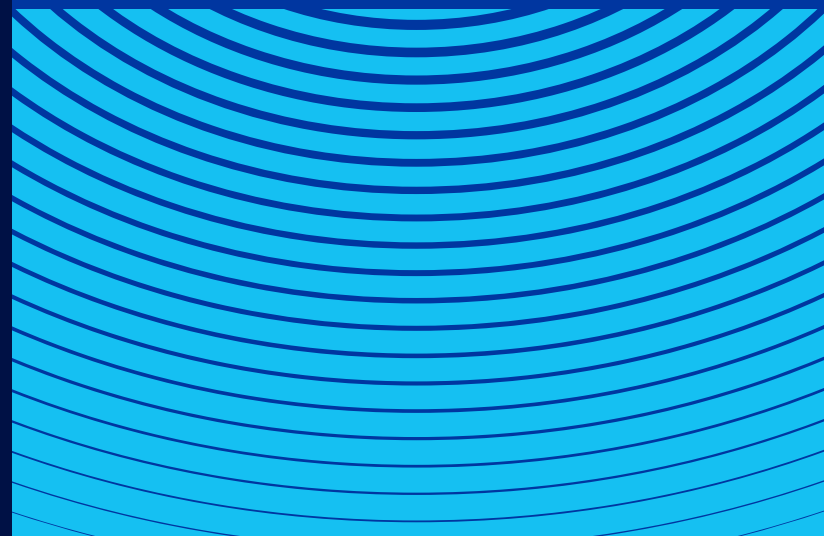

# bonus campaign guidelines



- Qualifying sales include qualifying underwritten supplemental plans with application dates October 1, 2023, to December 31, 2023.
- Plans must be issued and in force for a minimum of three months, with premium paid, to qualify for the bonuses. Bonuses are paid monthly, lapsed policies will be subject to charge backs.
- At least 15 qualifying supplemental plans must be sold during the qualifying period to earn the bonuses. Once the requirements have been met, the bonuses will apply to all applicable sales during the qualifying period.
